Description of necessary first aid measures

Inhalation

: Get medical attention immediately. Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. Ingestion

Section 7. Handling and storage

Precautions for safe handling

Conditions for safe storage, including any incompatibilities

Appropriate engineering controls
